Right from the Heart Ministries is a ministry whose mission is to reach and disciple people for Jesus Christ through the use of media. The organization uses secular media to connect with people as they conduct regular, daily activities. The broad reach of various media is a very cost effective way of spreading this message.

Radio: The radio ministry is comprised of the airing of one-minute "spots" on secular radio stations throughout the state of Georgia. These spots are designed to capture the attention of listeners and give them a message relating the Word of God to their everyday lives. The messages also include a "tag" that directs listeners to the ministry's web site, where they are encouraged to sign-up for daily devotionals. Over the past couple of years, we've started doing international radio spots in The Philippines and Poland. We've partnered with local pastors who translate our radio spots in order to reach the people of their cities. The radio ministry is the single largest expense item for Right From The Heart.

4b (Code:) (Expenses \$ 304,375 including grants of \$ 0) (Revenue \$ 0)

Television: The television ministry is similar to the radio ministry in that it produces short (:30-:60 sec) TV spots in which Bryant Wright presents a Biblical truth and relates it to everyday life. Due to rising costs of broadcast TV, most of the monthly expenses are now directed towards streaming or "on-demand" television. Unlike regular television, a viewer cannot skip these ads and must watch them in order to continue their programming. Ads on Broadcast TV are only purchased during strategic times/events that are guaranteed to have a large audience such as, NCAA Men's Basketball Tournament. Television expenses are the 2nd largest media expense of Right From The Heart.

4c (Code:) (Expenses \$ 140,558 including grants of \$ 0) (Revenue \$ 0)

Online: The internet ministry leverages the radio and TV ministries by providing the same content on the ministry web site, which can be downloaded by visitors. The ministry also offers a daily devotion which can be viewed on the web site, via email, RSS feed, Twitter, Facebook, and Instagram. Over the past year, the ministry has seen a fantastic response to paid online Google and social media ads. Viewers of these online ads are far more likely to give their email address and subscribe to the daily devotions than on radio or TV. It is also a far more cost-efficient form of ministry. Online expenses are the 3rd highest expense for Right From The Heart and could potentially surpass expenses for TV in the future.
